SUBJECT: TERMINATION OF YOUR NRC RADIOACTIVE MATERIALS LICENSE

By letter dated May 22, 2006, you informed the U.S. Nuclear Regulatory Commission (NRC) that you wished to terminate your NRC radioactive materials license and transfer all commitments regarding materials and authorized users made by Advanced Imaging Center of Pocatello to Portneuf Medical Center, NRC License No. 11-27384-01. This consent of transfer is requested due to the purchase of all assets of Advanced Imaging Center of Pocatello by Portneuf Medical Center. It is our understanding that Portneuf Medical Center agrees to abide by all constraints, conditions requirements, representations, and commitments identified in NRC License No. 11-29215-01 (Advanced Imaging Center of Pocatello). Review of the above document indicates that the transfer of control described above is in accordance with the Atomic Energy Act of 1954 (68 Stat. 919), including any amendments thereto, and we hereby give NRC consent to same pursuant to Section 30.34(b) of 10 CFR Part 30. Therefore, the commitments made by Advanced Imaging Center of Pocatello have been transferred to Portneuf Medical Center, NRC License No. 11-27384-01.

Based on these conclusions no further actions with respect to NRC regulated material is required and NRC license number 11-29215-01 for your facility at Pocatello, ID 83201, is hereby terminated.
