The purpose of this modification is to modify the statement of work to allow the contractor more flexibility in the course manual development and testing. Accordingly, the contract is hereby modified:

1. Section C, Subsection C.3.1., paragraph k, is deleted in its entirety, and substituted with the following in lieu thereof:

“The subject matter contained in the course manual(s) may take the form of written text prepared to supplement the course lectures and workshops, supporting information for presentations or workshop activities, or hard-copy versions of presentation graphics used during class presentations. The forms of the material contained in the manual, its level of detail, and order of presentation shall be at the discretion of the project officer. To the extent that the course manual includes text in chapter format, the provisions of Subsection C.4 shall apply to its preparation and incorporation.”

2. Section C. Subsection C.6.a., is modified to add the following to paragraph 6:

“Notwithstanding Subsections C.6.a(1) through C.6.a(6) of this contract, the Project Officer may, at his discretion, waive the testing requirements for Inspecting for Performance - Materials Version course sessions.”

This modification obligates no funds.

All other terms and conditions of the subject contract including the ceiling amount of \$224,950.00, remains unchanged.
