(2) Section B.3 entitled, "Consideration and Obligation-Firm-Fixed Price (Jun 1988)" is hereby deleted in its entirety and replaced with the following:

"The firm fixed price of this contract is \$185,104.24"

This modification obligates funds in the amount of \$22,818.64.

All other terms and conditions remain the same.
