Dear Mr. Maiers:

This is in reference to your letter dated March 13, 2006 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 37-17860-02. We have completed our initial review of your financial assurance submittal and have found that the Statement of Intent submitted by DCNR on behalf of PADEP is sufficient to meet the requirements of 10 CFR 30.35(f)(4). However, in order to complete our review, we need the following additional information. Please identify the specific documentation that authorizes the Secretary of DCNR to request funds from the appropriate funding body. Appendix A of Volume 3 of NUREG-1757, *Consolidated NMSS Decommissioning Guidance, Financial Assurance, Recordkeeping, and Timeliness*, provides guidance on preparation of a Statement of Intent, including the information requested in this letter.
