As we discussed, the text below is a proposed license condition regarding liability insurance. Please let me know if you have any comments.

USEC shall provide to the Commission, at least 120 days prior to obtaining licensed material, documentation of any liability insurance obtained by USEC for the ACP by that time or, alternatively, the status of USEC's efforts to obtain liability insurance. During the time that USEC is engaged in efforts to obtain liability insurance, USEC shall provide the Commission with status reports regarding those efforts. The status reports shall be submitted at a frequency of at least once every six months following issuance of a license. USEC shall notify the Commission within 30 days upon receiving notification of denial or approval of commercial liability insurance for the ACP. If commercial liability insurance is available, within 60 days of receiving notification of approval of commercial liability insurance, USEC shall provide proof of liability insurance coverage and a justification, for Commission review and approval, if USEC is proposing to provide less than \$300 million of liability insurance coverage.
