ORDER

(Establishing Tentative Case Schedule)

The Board hereby establishes the following tentative schedule for the Mandatory

Hearing Proceeding relating to System Energy Resources, Inc. (SERI) proposed Grand Gulf
early site permit (ESP). We stress, however, that this schedule is necessarily tentative.

As we pointed out in our Order of May 31, 2006, the Board has not yet determined what form the Mandatory Hearing in this proceeding will take.¹ We had anticipated that after we received and reviewed the materials specified in our April 19 Order that we would be able to choose the most efficient format within which to proceed, and at that time we would issue an order setting the schedule for this proceeding. However, in its Order of July 26, 2006, the Commission directed us to establish a schedule that would allow the Board to issue its decision in this proceeding by November 30, 2006. CLI-06-20, 63 NRC _ (slip op. at 15) (July 26, 2006).

¹ As the Commission pointed out "[t]he word 'hearing' can refer to any of a number of events, including trial-type evidentiary hearings, 'paper hearings,' paper hearings accompanied by oral arguments, [or] hearings employing a mixture of procedural rules." CLI-05-17, 62 NRC 5, 42-43 (2005) (footnotes omitted). The Commission did "not dictate any particular procedure in the current case[]." Id. at 43.

Accordingly, pursuant to the Commission's directive, we set out the following schedule which, to the degree that it varies from any earlier deadlines established by this Board, supercedes those earlier deadlines:

² Consistent with the Commission's Order dated July 26, 2006, we direct that no later than August 7, 2006, the NRC Staff produce to the Board an index describing all documents that it submitted to the ACRS and also to produce an index of and copies of all documents that the Staff received from the ACRS relating to the Grand Gulf ESP application.

As the Board continues with its examination of this matter we may well identify areas where we need additional information in order to complete our substantive review of the NRC Staff's work on safety and environmental matters, or we may determine that we have allocated too much time for a particular stage of the proceeding. Accordingly, as noted above, this schedule is necessarily tentative and may well be superceded by subsequent orders.³

As repeatedly recognized by the Commission in its various memoranda and orders relating to the Mandatory Hearing process, we are all (the Applicant, the NRC Staff, the Board and the Commission) trying to develop procedures that will insure efficient and meaningful Mandatory Hearings. This process is complicated by the fact that these are "essentially new process[es] where the agency lacks recent experience." Accordingly, as we all proceed through this Mandatory Hearing experience, flexibility and a spirit of cooperation will be required if we are to complete this proceeding within the time frame expected by the Commission.

It is so ORDERED.
