# SUBJECT: SHEARON HARRIS NUCLEAR POWER PLANT - NRC SECURITY BASELINE INSPECTION REPORT NO. 50-400/2006006

Dear Mr. Gannon:

On May 19, 2006, the NRC completed the onsite portion of a security baseline inspection at your Shearon Harris Nuclear Facility. Portions of Inspection Procedures 71130.01, Access Authorization, and 71130.08, Fitness for Duty, were completed at the Progress Energy Corporate office on February 10, 2006. The enclosed report documents the inspection results, which were discussed with Mr. Eugene Martin, at the corporate office, on February 10, 2006, and with Mr. B. Duncan and other members of your staff on May 19, 2006 and June 12, 2006.

This inspection examined activities conducted under your license as they relate to security and compliance with the Commission's rules and regulations and with the conditions of your license. The inspectors reviewed selected procedures and records, observed activities, and interviewed personnel.

Based on the results of this inspection no findings of significance were identified. However, licensee-identified violations which were determined to be of very low safety significance are listed in this report. The NRC is treating these violations as a non-cited violations (NCV) consistent with Section VI.A.1 of the NRC Enforcement Policy because of the very low safety significance of the violations and because they were entered into your corrective action program. If you contest these NCVs, you should provide a response within 30 days of the date of this inspection report, with the basis for your denial, to the Nuclear Regulatory Commission, ATTN: Document Control Desk, Washington DC 20555-0001; with copies to the Regional Administrator; the Director, Office of Enforcement, United States Nuclear Regulatory Commission, Washington, DC 20555-0001; and the NRC Resident Inspector at the Shearon Harris Facility.
