ORDER

(Setting Conference Call,
Granting Leave to File Reply Brief,
and
Reserving Date for Oral Argument)

In response to the Board's July 27 call for a Joint Status Report, the parties submitted such a report on August 2. That report indicates that the parties have been conferring to resolve various matters, and addresses much of what was contemplated in our July 27 Order by setting out (1) a proposed briefing process for resolving a privilege dispute about a key document, and (2) a proposed partial schedule for the remaining phases of the discovery process. The joint report also addresses the status of the parallel criminal case. The Board appreciates the cooperative efforts the parties have made to resolve many matters amicably.

Accepting the parties' view that it would be timely to hold a prehearing conference after "fact discovery" is completed (around year-end, according to one possible reckoning of the parties' plans), the Board would benefit from a much earlier clarification of certain matters, including -- before passing upon the proposed schedule -- the need for such an extensive time for discovery as the parties envision. To that end, a prehearing teleconference call, expected to last approximately 30-45 minutes, is hereby SET for Thursday, August 17, at 1:00 PM.

During that call, the Board will also advise the parties whether, in light of the Motion to Compel contemplated to be filed on behalf of Mr. Geisen by August 11, it expects to hold oral argument thereon. If so, argument on the motion would likely be set for the afternoon of Wednesday, September 6, following the late-August submittal of the Geisen reply (for which consented-to leave to file is hereby GRANTED) to the NRC Staff's response to the motion.

It is so ORDERED.
