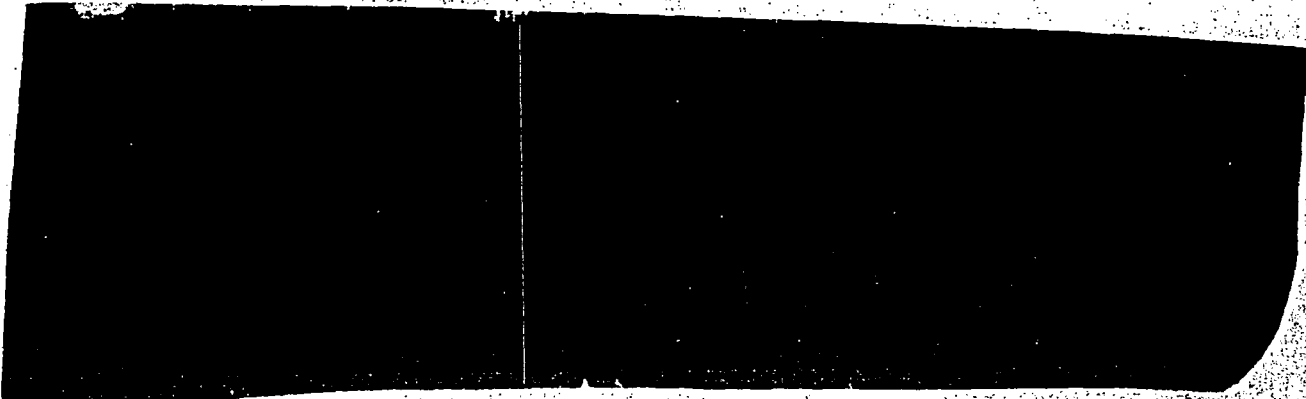

but i will go with the panel end result, since i can't attend.

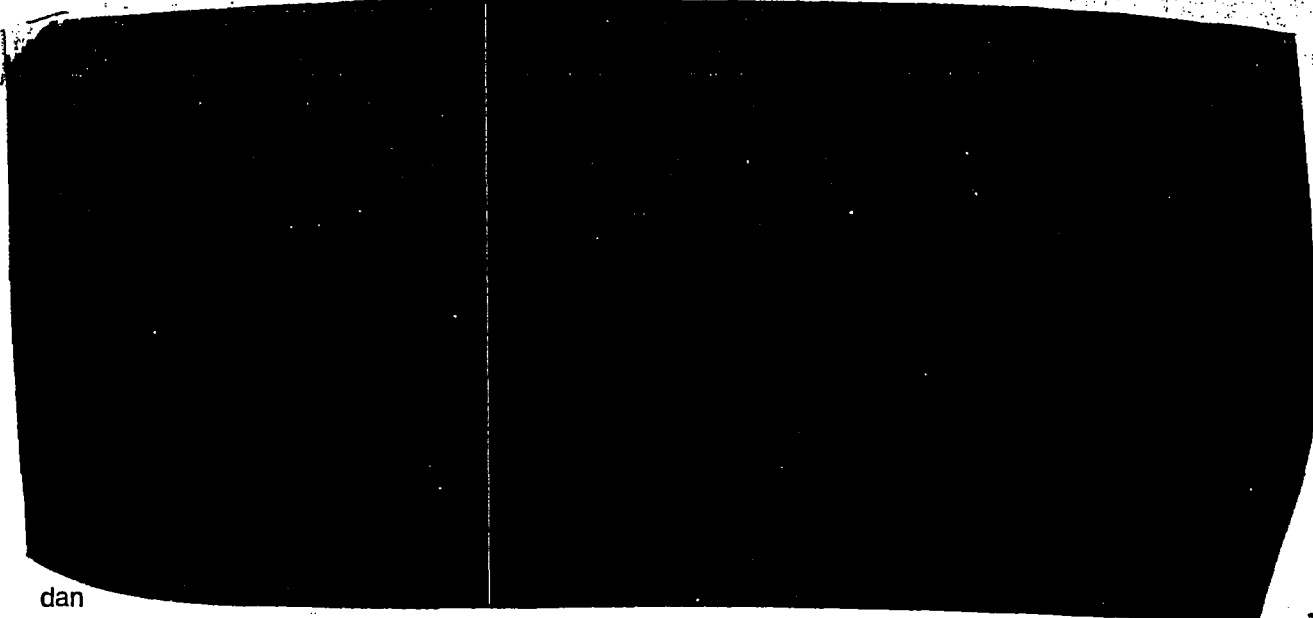
