Additional information is needed for completion of your license amendment, as follows:

1. University of Pittsburgh Medical Center (UPMC) South Side's letter dated 05/17/06, requested the addition of Edward G. Kaliman, M.D. to your NRC license as an Authorized User (AU) but did not specify a material authorization. Please confirm whether he should be listed for 35.200 only.
2. Your letter also stated that Dr. Kaliman was listed on NRC License Number 37-01626-04 issued to Sharon Regional Health System as recent as the year 2000. A review of the docket file for that license revealed that he was removed as an AU for 35.200 on 02/05/93. Since this is beyond seven years, you will need to provide specific documentation that Dr. Kaliman has related continuing education and experience (including dates) since listed as an AU, in accordance with 10 CFR 35.59.
