Dear Mr. Gallimore:

This letter has been prepared at your request to indicate that Potesta & Associates, Inc.'s (POTESTA) intent to take possession of a portable nuclear density gauge (Troxler Model 3430) on Friday, July 24, 2006. The details related to POTESTA's offer to purchase this gauge were included in previously prepared correspondence dated June 7, 2006. POTESTA has completed the required forms for submittal to the US Nuclear Regulatory Commission (NRC) requesting termination of Kanawha Eagle Coal's (KEC) current U.S. Nuclear Regulatory Commission (NRC) materials license (NRC Form 314, Certificate of Disposition of Materials). POTESTA has indicated on this form KEC's intent to transfer the portable nuclear gauge to POTESTA's Charleston, WV office.

POTESTA has contacted Mr. Jim Schmidt of the NRC-Region II, Division of Nuclear Materials Safety located in King of Prussia, PA to discuss the specific reporting requirements to terminate KEC's current license as well as any additional requirements or notifications that may be required for POTESTA to take possession of the gauge. Mr. Schmidt indicated that the only requirement was submittal of NRC Form 314 to terminate KEC's current license and that there would be no additional submittals required for POTESTA to take possession of the gauge.

Following submittal of the attached Form 314, the NRC as part of the review and confirmation process will contact POTESTA to confirm that the gauge is indeed in our possession. Please notify me when the form is submitted and follow-up by providing a copy of the authorized form. POTESTA has attached a check to this correspondence in the amount of \$3,500 as agreed to purchase the gauge.






