Per my previous letter to your office dated March 21, 2006, this letter is to request an amendment to NRC license no. 37-28641-01 for the licensee, Consol Pennsylvania Coal Company. 

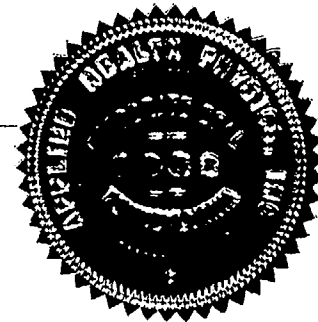
