## 2) Physical Description

This shipment consists of 48 x 48Y Cylinders loaded on 2 lash barges (24 cylinders per barge – one barge to Almelo and one barge to Gronau). RADIOACTIVE MATERIAL, URANIUM HEXAFLUORIDE, non fissile or fissile-excepted. Total net weight of U – 389,063 kgs.

## 3) Transportation and Route Schedule

The surface transportation from Metropolis, IL to Paducah, KY will be the responsibility of RSB LOGISTIC SERVICES INC. The inland barge transport and ocean transportation from Paducah, KY to Brake, Germany will be the responsibility of Forest Lines Inc. 
