## Attachment

### NRC Guidelines for Future Stakeholder Interactions on West Valley

The staff's guidelines for NRC's future stakeholder interactions on West Valley are:

- 1) For NRC's West Valley activities under the Atomic Energy Act, the policy of NRC's Management Directive 3.5 will be used for any meetings between NRC staff and one or more outside persons on the subject of NRC's license at West Valley. Likewise, the policy of NRC's Management Directive 3.4 will be used for the release of documents related to the NRC's licensing of the site.
- 2) For the NRC's West Valley activities under the WVDP Act, any meetings<sup>1</sup> between the NRC staff and one or more outside persons on subjects covered under NRC's WVDP Act review and consultative responsibility will be publically noticed under the criteria for holding public meetings in Management Directive 3.5. It is recognized that DOE is not an applicant or a licensee with respect to West Valley under the WVDP Act, and that, as a Federal Agency, Management Directive 3.5 does not normally apply to DOE. As a result, Management Directive 3.5 does not include procedures for addressing the sensitivities of federal agencies for release of preliminary or draft documents that may occur during a completely open series of meetings. Therefore, if upon receiving these guidelines for stakeholder interaction, DOE believes that under the WVDP Act it would like to hold closed meetings that would not specifically be provided for by Management Directive 3.5, NRC will request DOE to provide alternative criteria for holding closed meetings with the NRC. In evaluating DOE's criteria, NRC will consider comments from other agencies and interested persons. The staff believes that the NRC decommissioning criteria for DOE under the WVDP Act should be developed through an open process. NRC thus specifically intends that all meetings concerning the prescription of decommissioning criteria should be open to public observation.

The exchange of documents between NRC and DOE, related to all of NRC's WVDP Act activities, will be made available for public inspection as stipulated in the NRC-DOE Memorandum of Understanding on West Valley, Section 3(A)(2).

- 3) For NRC's West Valley activities under National Environmental Policy Act, meetings between NRC staff and the staff of the other agencies involved in the West Valley EIS (DOE and NYSERDA) on subjects covered under NRC's responsibility as a cooperating agency will not be open to public observation consistent with the approach generally used with cooperating agencies. Likewise, predecisional documents or presentation materials submitted by DOE and NYSERDA for NRC review will not be made available to the public, to the extent allowed by law, at the request of the submitting agency. While neither the Council on Environmental Quality's (CEQ) nor NRC's regulations address public participation in the drafting or review of preliminary or predecisional National Environmental Policy Act documents, it should be noted that the public had the opportunity to comment on the draft EIS and will have the opportunity to comment on any draft supplemental EIS documents.
