SUBJECT: INTERIM LICENSE ANNEX PELLETTING SYSTEM


Enclosed are two copies (each) of an Interim License Annex for the Westinghouse Columbia Fuel Fabrication Facility. In accordance with Safety Condition S-5 of Materials License SNM-1107, this Annex was prepared by adding tables of Environmental/Radiological and Chemical/Fire controls to the blank sections titled "Environmental Protection and Radiation Safety Controls" and "Chemical Safety and Fire Safety Controls" in the Enhanced Criticality Safety Evaluation License Annex (submitted in accordance with Safety Condition S-2). It was not submitted with the other eleven (11) Interim License Annexes on November 30, 2000, because at that time it was scheduled to be completed as an ISA License Annex to be submitted by years end. It turned out that that schedule could not be met.

As described in July 14, 2000 Westinghouse letter NRC-00-25, that transmitted an upgrade of the Uranyl Nitrate Bulk Storage System Integrated Safety Assessment (ISA) License Annex ("ISA Summary"), these Interim License Annexes will be upgraded to the new format as their respective ISA's pass through the final "Safety-Significant Controls Quality Assurance Process" (by December 31, 2002).
