My apologies for the omission of the items you mentioned in your letter on August 3, 2006. I have addressed these items and will discuss them in turn below.

Addition 1: I have included a letter from **Lon Slane, President**, Dilon Technologies, LLC.

Addition 2: There was an error in Item 5 (Radioactive Materials) of the application. We have not received the Survey Meter Check Source (Part Number 01-5196) from Ludlum Measurements yet, and I had used a representative part number for the Cs-137 source. I have contacted Ludlum Measurements and they have provided me with the manufacturers name (**Spectrum Technique**) that provides the source to them. I contacted Spectrum Technique and they provided me with the model number (**CS-137S1**) for the 1- μ Ci Cs-137 source. The source will be a 1-inch diameter disk, presumably a Type D source.


Addition 3: There was an omission in Item 8 (Training for individuals working or frequenting restricted areas) of the application. The statement "**Refresher training for non-authorized users working in the Hot lab will be required on an annual basis.**" should be included in Item 8.

Addition 4: There was a typo in Item 10 (Material Receipt and Accountability) of the application. The survey instruments that will be used meet the radiation monitoring instrument specifications published in **Appendix N to NUREG - 1556, Vol. 7, 'Program-Specific Guidance About Academic, Research and Development, and Other Licenses of Limited Scope,'** dated December 1999.

I hope that the additional information in this letter will be sufficient to address the missing information on the Application for Materials License that was filed on behalf of Dilon Technologies. If it would be more appropriate for me to forward a revised copy of

the application with these additions, I will be happy to do so. Please let me know if that would be required. Thank you.
