**OPPORTUNITY TO COMMENT ON DRAFT REVISION TO STP PROCEDURE SA-700,  
“PROCESSING AN AGREEMENT” (STP-06-073)**

**Summary:** This letter provides the States and appropriate U.S. Nuclear Regulatory Commission (NRC) offices with an opportunity to comment on the draft revision to the STP Procedure SA-700, “Processing an Agreement.”

**Purpose:** The Commission has long held the view that its regulatory processes should be predictable and stable. In this connection the Office of State and Tribal Programs (STP) has reviewed its Procedure, SA-700 with a view towards greater clarity and a more predictable and stable approach. The objective is to create an environment in which a prospective Agreement State can proceed with confidence that its application will receive timely and meaningful review and expeditious action by the NRC.

The STP Procedure SA-700 provides for the effective, efficient, and timely review of the request by a State for an Agreement or for an amendment to an existing Agreement. This document also provides an orderly transition in the discontinuance of regulatory authority by the NRC and assumption thereof by the State, as well as supports the necessary budgetary planning process that accompanies the transition.

In addition to the changes identified in the enclosure, we are considering two additional enhancements to our process. We are examining the feasibility of establishing two different review criteria; a new criteria for the completeness review and the existing criteria for the detailed technical review of the application. While the present use of the same criteria for both the acceptance and detailed technical review allows the review team flexibility in their analysis, there may be some benefit to applying review criteria designed specifically for each phase of the review process. We are also considering the benefit of conducting a site visit by one or more members of the review team during the review process.

**Request for Comment:** The changes to STP Procedure SA-700 are in redline/strikeout format. We would appreciate receiving your comments within 30 days from the date of this letter. Our staff plans to finalize the document after the 30 day comment period has ended.
