This is an official letter of the closing of Cardiac for Life, located at 130 Kinderkermack Road, Suite 204, River Edge, N.J. 07661 with your acknowledgement not to perform any nuclear studies at this location. On Wednesday, July 26, 2006, the following sources inventoried and were removed. Nuclear Diagnostic Products, Inc. has the sources in there possession for disposal.
