### **MATERIALS LICENSE**

Pursuant to the Atomic Energy Act of 1954, as amended, the Energy Reorganization Act of 1974 (Public Law 93-438), and Title 10, Code of Federal Regulations, Chapter I, Parts 30, 31, 32, 33, 34, 35, 36, 39, 40, and 70, and in reliance on statements and representations heretofore made by the licensee, a license is hereby issued authorizing the licensee to receive, acquire, possess, and transfer byproduct, source, and special nuclear material designated below; to use such material for the purpose(s) and at the place(s) designated below; to deliver or transfer such material to persons authorized to receive it in accordance with the regulations of the applicable Part(s). Licensed material shall be used only at the licensee's facilities located at DNSC Hammond Depot, 3200 Sheffield Avenue, Hammond, Indiana; DNSC New Haven Depot, State Route 14, New Haven, Indiana; DNSC Curtis Bay Depot, 710 Ordnance Road, Baltimore, Maryland; DNSC Somerville Depot, 152 US Highway Route 206 South, Somerville, New Jersey; DNSC Binghamton Depot, Hoyt Avenue, Binghamton, New York; and DNSC Scotia Depot, Route 5, Scotia, New York.
- 11. A. Licensed material shall be used by, or under the supervision of, Michael J. Pecullan or individuals who have completed the training described in the application dated September 10, 1999, and the letter dated January 7, 2000.
  - B. The Radiation Safety Officer for this license is Michael J. Pecullan.
- 12. The licensee is authorized to transport licensed material in accordance with the provisions of 10 CFR Part 71, "Packaging and Transportation of Radioactive Material."

- 13. The licensee may use the following Derived Concentration Guideline Level (DCGL) for decommissioning of the licensee's facilities at the DNSC Binghamton Depot, Hoyt Avenue, Binghamton, New York, with the intention of release of the facility for unrestricted use: not more than 37.3 disintegrations per minute per 100 square centimeters (37.3 dpm/100 cm²) of natural thorium and 110 dpm/100 cm² of natural uranium.
- 14. Not withstanding 10 CFR Section 20.1003, definition of weighting factor, the licensee may utilize the adult conversion factors from Federal Guidance Report Number 13 for the decommissioning of the licensee's facilities at the DNSC Binghamton Depot, Hoyt Avenue, Binghamton, New York.
- 15. Except as specifically provided otherwise in this license, the licensee shall conduct its program in accordance with the statements, representations, and procedures contained in the documents, including any enclosures, listed below. The Nuclear Regulatory Commission's regulations shall govern unless the statements, representations, and procedures in the licensee's application and correspondence are more restrictive than the regulations.
