3) Transportation and Route Schedule

The vessel will sail from Hamburg, Germany on August 12, 2001. The ocean transportation from Hamburg, Germany to Montreal, Quebec, Canada will be the responsibility of CANMAR Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about August 20, 2001. The containers will then be loaded onto the rail for importation to Detroit, MI.
