

The purpose of this modification is to obligate FY'05 funds in the amount of \$130,000.00, thereby increasing the obligated amount of the subject contract from \$944,000.00 to \$1,074,000.00.

Accordingly, the following change is hereby made:

Subsection **B.24 CONSIDERATION AND OBLIGATION**, is deleted in its entirety and substituted with the following in lieu thereof:

**"CONSIDERATION AND OBLIGATION**

- (a) The total estimated cost to the Government fo full performance under this contract is \$2,103,512.00.
- (b) The amount currently obligated by the Government with respect to this contract is \$1,074,000.00.
- (c) It is estimated that the amount currently allotted will cover performance through February 28, 2005."
