Earlier today I received the e-mail below from Timothy Crisler (Corporate Communications Specialist for Entergy, Grand Gulf Nuclear Station), entering on behalf of Mr. Russ Brian (Interim Vice President, Grand Gulf Nuclear Station) a request to speak at the limited appearance session scheduled for Monday August 28.

Limited appearance sessions are governed by 10 CFR 2.315(a), which states that only persons "not a party (including persons who are affiliated with

or represented by a party) may, . . . be permitted to make a limited appearance." See also Southern California Edison Co. (San Onofre Nuclear Generating Station, Units 2 and 3), ALAB-212, 7 AEC 986, 992 (1974) ("[e]very construction permit application entails a mandatory hearing to which the applicant(s) and the staff are automatically parties").

Given the fact that Mr. Brian is affiliated with the applicant-SERI, please advise the Board via e-mail by Monday, August 21, as to your respective positions on the propriety (or not) of his request to enter an oral limited appearance statement.
