Dear Mr. President:

- The Nuclear Regulatory Commission (NRC) is not perceived as an objective force, capable of effectively regulating the nuclear industry.
- The NRC is widely perceived as a group that automatically and arbitrarily approves any measure that the president may endorse, with total disregard to the specifics of a proposal or the safety of the public.
- The NRC has a track record of approving nuclear plants of faulty and obsolete design. It regularly approves the operation of nuclear plants designed pre 9/11, never designed to be defended against terrorist attack against the plant itself or poorly stored waste (spent fuel rods haphazardly stored on site).

Recently, in California, the NRC clearly demonstrated its non-objective bias where three judges of the 9th U.S. Court of Appeals agreed with area residents who feared a potential attack. The NRC found that "an attack was remote and speculative and therefore unnecessary to consider." "Unnecessary to consider" - where have they been? A terrorist attack is certain. We don't know where or when. But, we must "consider." We cannot leave ourselves vulnerable.
