2) Physical Description

This shipment will consist of 93 modules of Depleted Uranium in 12x 20' ocean containers. The total weight of the shipment is 102,000 kgs. of uranium.

3) Transportation and Route Schedule

The vessel will sail from Le Havre, France on October 26, 2000. The ocean transportation from Le Havre, France to Montreal, Quebec, Canada will be the responsibility of Canada Maritime Steamship Line. The vessel will unload at Montreal, Quebec, Canada on or about November 2, 2000. The containers will then be loaded onto the rail for importation to Detroit, MI. The containers will enter the USA at Detroit, MI on or about November 11, 2000, and will continue on rail to customer siding in Clive, Utah.
