The structural analysis will use modeling software to demonstrate that the package design meets the requirements of Title 10 Code of Federal Regulations, Part 71 for the impact limiter and the cask body. Staff suggested bench marking may be required to establish the applicability of the software for this application. Furthermore, the staff discussed the need for detailed discussion of the modeling methodology in its Safety Analysis Report.
