SAFETY EVALUATION REPORT Model No. 880 Series Packages Certificate of Compliance No. 9296 Revision No. 6

SUMMARY

By application dated July 19, 2006, QSA Global, Inc. (QSA or the applicant), submitted an amendment request for Certificate of Compliance No. 9296, for the Model No. 880 series packages. QSA requested the incorporation of an alternative length for the lock screws on the selector ring retainer of the Model No. 880 series packages. Based on the statements and representations in the application, the staff agrees that these changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.

EVALUATION

By application dated July 19, 2006, QSA submitted an amendment request to revise Drawing No. R88000. Revision J of the drawing incorporates an alternative length for the lock screws. The currently approved lock screws allow for an extra 0.02 inch screw protrusion from the selector ring retainer. Elimination of the screw protrusion would not affect the safety performance of the lock assembly. Condition No. 5(a)(3) was revised to reflect Revision J, as the current version of Drawing No. R88000.

The staff reviewed the documents referenced in the certificate and determined that the documentation was available and complete. The staff also reviewed the package's operations and maintenance program for the package and found them to be adequate.

CONCLUSION

The Certificate of Compliance has been revised to show the latest version of Drawing No. R88000, Revision J, which allows the previously approved screw length as well as an alternative screw length for the lock screws. These changes do not affect the ability of the package to meet the requirements of 10 CFR Part 71.
