As I wrote last week, your Deputy Director Margart Federline's Petition Review Board rejected my 2.202 petition of July 12, 2006 on the basis of Ms. Federline's arbitrary definition of the word "significant" which bears no relation to any dictionary definition or to any NRC documentation. This behavior does not conform to the NRC values published on your web site.

Unless I hear by Thursday afternoon that Ms. Federline's PRB is reconsidering the rejection of the petition, and has agreed to use a standard, dictionary definition of the word "significant" in doing so, I will file the attached draft complaint in court. (Attached is at ML062490073)
