## INSTRUCTIONS TO STUDENTS

**ACCEPTANCE:** This is to advise you that those individuals in Enclosure (1) have been accepted for participation in the training course (G-205) "Root Cause/Incident Investigation Workshop." This course is scheduled to be presented October 30-November 3, 2006, at the NRC Region III (R-III) Office, 2443 Warrenville Road, Suite 210, Lisle, IL 60532. Telephone (630) 829-9500.

**COURSE:** The course will be conducted beginning at 8:00 a.m. and ending at 4:00 p.m. each day. The workshop is scheduled to be completed at 2:00 p.m. on Friday, November 3, 2006.

**LODGING AND TRAVEL:** You should plan to arrive on Sunday, October 29, 2006, and depart on Friday, November 3, 2006. Participants must make their own lodging and travel arrangements. ## **DIRECTIONS FROM O'HARE AIRPORT TO R-III OFFICE**

1. Start out going Southwest on COMMERCIAL VEHICLES towards TERMINAL RETURN/AIRPORT EXIT by turning right.
2. COMMERCIAL VEHICLES becomes TERMINAL RETURN/AIRPORT EXIT.
3. Take the I-190 EAST ramp towards CHICAGO LOOP.
4. Take the I-294 SOUTH exit and go about 10 miles (There is a \$.80 toll on the way).
5. Take I-88 WEST RAMP towards AURORA and go about 10 miles (There is another \$.80 toll right after getting on I-88 West).
6. Take the ROUTE 53 SOUTH exit and stay in the right lane to make a RIGHT (West) turn on Warrenville Road (first light, right after you get off the tollway).
7. After you turn right, you will go through two more traffic lights (about a mile). Then there will be one last light. Turn LEFT (South) at the light and enter WESTWOOD OF LISLE.
8. As you turn in, you will see two buildings. As you approach a "T" intersection, take a right and go to the next entrance. Make a left and proceed to the rear of the building. Once you find a place to park, enter the building and head to the second floor. Make a left out of the elevator and another left towards the NRC Office.
