Fitness for Duty Program Six Month Performance Report January – June 2006

PROGRAM SUMMARY:

The Waterford 3 annual random testing rate is 50 percent. During this reporting period, approximately 28.0 percent of the population has been randomly tested. The rate of positive tests from random testing is 0.00 percent.

POSITIVE RESULTS:

As shown on the attached sheets, there were seven positive tests during this reporting period. The samples that confirmed positive for Marijuana were confirmed at the NRC cut-off of 100 ng/ml.

MANAGEMENT ACTIONS:

During this reporting period, four for-cause tests were requested. Two of the four were requested because of accidents. Both of these samples returned negative results. A third was requested due to a smell of alcohol. This sample was confirmed positive for alcohol. Management was notified, and the individual's access was denied. The file was annotated to reflect the positive result and denial of access. A fourth was requested due to self-admitted contact with a substance that could have been an illegal drug. This sample tested negative.

One licensee employee and three contractors tested positive during pre-access testing. One of these individuals submitted a sample that was suspect due to temperature. A second sample was collected under the category of 'Other'. This sample also tested positive. Management was notified, and these individual's access request were denied. The files were annotated to reflect the positive results and denials of access.

One contractor gave a sample during pre-access testing that was suspect due to appearance. A second sample was collected under the category of 'Other'. This sample tested positive. The individual admitted trying to adulterate his sample with a cleanser. Management was notified, and the individual's access request was denied. The file was annotated to reflect the positive results and denial of access.

Eight follow-up samples were collected from licensee employees, and two were collected from contractors during this reporting period. All samples returned negative results.

One individual that reported for a random test blew an alcohol result that was below the positive cut-off but high enough that the individual could have been positive when

first reporting to work. The individual's management was notified of the results. The individual was denied access in accordance with Company procedures.

EVENTS REPORTED TO THE NRC:

During this reporting period, there were no violations of the fitness for duty program that were reportable.

PROGRAM EVALUATION:

No programmatic problems were identified during this reporting period.
