Dear Mr. Baugh:

This is in reference to your letter dated July 28, 2006 providing financial assurance for decommissioning for Nuclear Regulatory Commission License No. 29-15354-01. We have received as part of this action amendment 6, 7, and 8 to your Letter of Credit, Certificate of Events, and Certificate of Resolution as part of this licensing action. In order to continue our review, we need the following additional information:

1. The current Certification of Financial Assurance dated April 27, 2005 does not reflect the prescribed value of \$225,000. Please submit a new Certification of Financial Assurance. Please follow closely the recommended wording as listed in our Model Certification of Financial Assurance found on page A-23 in Appendix A, to Volume 3 of NUREG-1757. Guidance for Certification of Financial Assurance may be found starting on page A-17 to Volume 3 of NUREG-1757.
2. The current Standby Trust Agreement dated January 22, 1991 needs a supplemental letter or amendment which states that the "Grantor" is now sanofi-aventis U.S. Inc. Additionally, a new Trust agreement Schedule A needs submitted which reflects the new prescribed amount and name of licensee. Please follow closely the Model Standby Trust Agreements Schedules listed on page A-165 to Volume 3 of NUREG-1757.

Alternatively, you may submit a new Standby Trust Agreement to replace the January 22, 1991 agreement. Guidance for Standby Trust Agreement is located starting on page A-153 to Volume 3 of NUREG-1757.
