Dear Mrs. Xu:

In reference to the letter dated July 27, 2006, I want to clarify the following:

1. The statement of Mr. Carmelo Pérez's in his letter of July 3, 2006 that HIMA Hospital acquired the San Pablo Hospital assets is incorrect; the buyer was Centro Médico del Turabo, Inc. The Nuclear Medicine Departments of all the hospitals under Centro Médico del Turabo, Inc. will be operating under their own licenses (Attachment I).

As a result of the transaction, all hospitals were renamed Hospital HIMA•San Pablo. Hospital Interamericano de Medicina Avanzada has been changed to Hospital HIMA•San Pablo Caguas, as shown in the hospital's license recently received (Attachment II).

2. The rest of the information contained in Mr. Pérez's letter of July 3, 2006 is correct.



- B. The following individuals are authorized users for medical use as indicated:

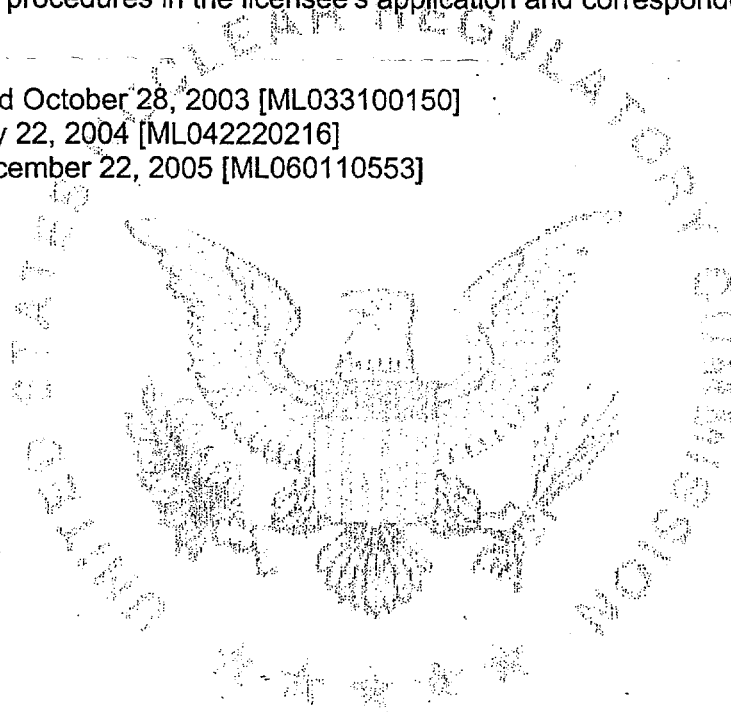
