Members of the Nuclear Regulatory Commission:

Building new reactors at North Anna will add further stress to the already-damaged water resources, both local and regional water. It would also add to current problems of radioactive waste and security from terrorism. Problems about increased water evaporation from the new reactors, and the effect of this water loss on lake levels and on the downstream flow into the North Anna River, have not been resolved. Water levels affect boating and recreation on the lake, downstream fisheries, and our supply of drinking water. Dominion Power could resolve these issues by building a dry cooling tower for the new reactors, or by investing in renewables and in energy conservation and efficiency and conservation. We have a power company which refuses to act for the long-term benefit of its customers. We need you to act in the interest of local citizens, finding safe ways to provide us with our power.
