I am writing regarding the recent recognition of American Board of Radiology's (ABR) certification process for Diagnostic Radiology under the requirements of 10 CFR 35.290 and 35.392. In your communications with the U.S. Nuclear Regulatory Commission (NRC), ABR stated that its certification requirements have been modified to comply with the 2005 revision to the training and experience (T&E) requirements in 10 CFR Part 35. In your letter of June 19, 2006, you also stated that ABR, effective June, 2006, altered its certificates to indicate to NRC which diplomates have fulfilled all NRC T&E requirements under the board certification pathway by adding the designation "AU-eligible" to the certificates. While this addresses diplomates being certified from June, 2006, forward, the ABR has not addressed whether it is able to determine if there are diplomates who have obtained their ABR-Diagnostic Radiology certification prior to June, 2006, who also satisfy all of NRC's training and experience requirements under the board certification pathway and whether ABR can issue "AU-eligible" certificates accordingly. Therefore, the NRC is requesting that ABR provide this information. In addition, please provide the method that ABR will use to verify that the diplomates' qualifications meet the 10 CFR Part 35 T&E and exam requirements for diplomates who have obtained their ABR-Diagnostic Radiology certification prior to June, 2006, and are seeking status as an authorized user under the board certification pathway.
