Dear Ryan and NRCREP:

I am very concerned about safety from anything nuclear. To reclassify low level radioactive waste sites is very hazardous as they will be radioactive for thousands of years and very dangerous. Some can give a lethan dose in less than one hour!

We need to INCREASE control over radioactive waste, not decrease or eliminate it.

We support classification and reulatory control of long lasting wastes such as depleted uranium in facilities designed for their longevity, NOT low level waste sites. You should put your efforts into better, increased control of radioactive materials.

I oppose risk informed regulation for both the reactor and materials programs. Effects on our health have been ignored and underestimated.

NRC should be protecting the public rather than permitting these risks.

I support regulations that prevent release and exposure rather than legalizing contamination and leakage.

Please strengthen your low level waste management and disposal requirements.

We the people need prevention of exposure to radioactive wastes.

We advocate complete and permanent rejection on the proposed rule that would have generically deregulated nuclear waste.
