This also refers to the telephone discussion between you and me on September 1, 2006, in which you agreed to provide additional information and clarification concerning the mobile nuclear medicine program that will more closely align with the information requested in NUREG 1556, Vol. 9, Rev. 1, Appendix V. Please submit this information to my attention and reference control number 315534.

Please note that we have reformatted Condition No. 12 at this time to remove all references to excluded and /or restricted authorizations, including but not limited to authorizations such as "generators, xenon-133, aerosols, cardiovascular clinical procedures, etc."

Please be reminded, however, that you are still bound by the restrictions imposed by the excluded and/or restricted authorizations contained in documents incorporated into your license in Condition No. 15 of your license.
