



I applaud this effort to inform the public about agency security initiatives and approve of the draft agenda submitted by the Office of Nuclear Security and Incident Response (NSIR) for a September 14, 2006 meeting. I further believe the requirement to seek Commission approval for staff-level public meetings on security issues – as outlined in a June 4, 2002, Staff Requirements Memorandum (M020516B) – is no longer relevant. Five years after September 11th, I am confident the staff fully understands Commission policy on communicating effectively with the public on security matters and believe the responsibility for setting agendas for future staff-level public meetings on security is most appropriately delegated back to NSIR.




