THE USE OF EXPERT ELICITATION IN THE LICENSING PROCESS FOR A POTENTIAL HIGH-LEVEL RADIOACTIVE WASTE REPOSITORY AT YUCCA

Dear Mr. Malsch:

I am responding to your letter dated, August 11, 2006, regarding the U.S. Department of Energy's (DOE's) use of expert elicitation in the development of its license application for Yucca Mountain. Specifically, you requested that the U.S. Nuclear Regulatory Commission (NRC) advise the DOE that it is unacceptable to use unqualified data through the expert elicitation process. You also expressed concern that the NRC's guidance on the expert elicitation process is ambiguous.

As such time as DOE submits a license application, the NRC expects it to be a high-quality application that would include technical analyses based upon, for example, software, models, and data that are reliable, transparent, and traceable. The NRC will, to the extent necessary and appropriate, perform independent activities including reviewing data and quality assurance processes as part of the license application review.

As part of our prelicensing interactions activities, the NRC staff, among other things, monitors DOE's implementation of its quality assurance program, and has communicated the results in NRC observation audit reports and other documents which are available on the NRC website at www.nrc.gov. The staff will continue to monitor implementation of DOE's quality assurance program as part of our prelicensing activities with DOE. The NRC will be mindful of the concerns raised in your letter during our review of any license application submitted by DOE. In keeping with our customary practice, we will take those steps that may be necessary to
