 The purpose of this modification is obligate the remaining funds on the original Request For Procurement Action and to modify clause A.1 (a) Consideration and Obligation--Delivery Orders (Jun 1988). This action is being done as the GSA Schedule was extended to October 7, 2006.
 The clause A.1 (a) is hereby modified as follows:
 (a) The total estimated amount of this contract for the products/services ordered, delivered, and accepted under this contract is \$62,000.00 (July 12, 2006 through August 7, 2010).
