The purpose of this modification is to acknowledge issuance of Work Orders: 001 - Oyster Creek, 002 - Pilgram, 003 - Vermont Yankee, 004 - FitzPatrick, 005 - Susquehanna, 006 - Wolf Creek and allot \$202,700.00 in incremental funding to the contract for the work orders.

Accordingly, the following change is hereby made:

Under Subsection B.4 - <u>CONISERATION AND OBLIGATION/CONTRACT CEILING</u>, Paragraph b is deleted in its entirety and the following is substituted in lieu thereof:

"b. The amount presently obligated with respect to this contract is \$411,700.00. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph a above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk."

The total amount obligated for the contract is increased by \$202,700.00, from \$209,000.00 to \$411,700.00.

All other terms and conditions under this contract remain unchanged including the ceiling amount of \$936,676.15.
