Dear Mr. Lawyer:

As the Radiation Safety Officer for The Heart Group in Lancaster, PA, I have overseen Dr. McKernan's training in the specified areas of your July 5, 2006, letter. Specifically, she has:

1. Overseen the ordering, receiving and unpacking of radioactive materials safely and performing related radiation surveys in our lab.
2. Performed quality control procedures on instruments to determine activity dosages and performed checks for proper operation of survey meters under my control.
3. Done calculations, measuring, and safely preparing of patient or human research subject dosages and administered them in our lab.
4. Used administrative controls and reviewed them to prevent medical event involving the use of unsealed byproduct material.
5. Has gone over and used procedures for safely containing spilled radioactive material and used proper decontamination procedures as needed and instructed.
6. Administered radioactive drugs to patients in our lab under my supervision.
7. Eluting generator systems appropriate for preparation of radioactive drugs for imaging and localization studies, measuring and testing the eluate for radionuclidic purity, and processing the eluate with reagent kits to prepare labeled radioactive drugs. This portion was done at CardinalHealth under the supervision of Bob Grobinski, RPh, BCNP on September 13, 2006, letter enclosed.




