The purpose of this modification is to exercise option year two in accordance with Federal Acquisition Regulation Clause 52-217-9, entitled, "Option to Extend the Term of the Contract," thereby extending the delivery order period of performance through September 25, 2007. As a result of this action, the delivery order cost ceiling is increased by \$5,297,607.41 from \$22,114,247.63 to \$27,411,855.04.

Accordingly, the following changes are hereby made:

1. Under the Section entitled, "CONSIDERATION AND OBLIGATION," Paragraph a is deleted in its entirety and substituted with the following in lieu thereof:

"(a) The total estimated amount (ceiling) for the products/services ordered, delivered, and accepted under this delivery order is \$27,411,855.04. The Contracting Officer may unilaterally increase this amount as necessary for orders to be placed with the contractor during the delivery order period of performance."

2. The Section entitled, "Duration of Contract," is deleted in its entirety and substituted with the following in lieu thereof:

"The ordering period for this delivery shall commence on September 26, 2003, and will expire on September 25, 2007. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. There are no option periods remaining this contract."

All other terms and conditions under this delivery order remains unchanged.
