 The purpose of this modification is to: 1) exercise Option Year One, for a period of performance from September 30, 2006 through September 29, 2007, in accordance with Federal Acquisition Regulation clause 52.217-9, Option to Extend the Term of the Contract, and 2) increase the total amount of the contract (ceiling) by \$173,194.50 for Option Year One, increasing the total ceiling by \$173,194.50, from \$275,799.20 to \$448,993.70.
 No funding is provided, as additional funds will be obligated on each task order issued. A 60-day preliminary written notification of NRC's intent to exercise this option was mailed to Millican & Associates, Inc. on July 21, 2006. All other terms and conditions of this order remain the same.
