

This Modification No. 2 exercises option period 1 of the contract and obligates additional funds in the amount of \$104,000. Accordingly, the following changes are hereby made:

1. Section B.3 CONSIDERATION AND OBLIGATION. Option Period 1 increases the contract ceiling by \$398,932.00 from \$749,948.00 to \$1,148,880.00. Accordingly, the first sentence in paragraph (a) is revised to read as follows:

(a) The total estimated amount of this contract (ceiling) for the products / services ordered delivered and accepted under this contract is \$1,148,880.00.

2. Section B.3 CONSIDERATION AND OBLIGATION. This modification obligates \$104,000, increasing the obligated amount from \$656,866.00 to \$760,866.00. Accordingly, paragraph (b), first sentence is revised to read as follows:

(b) The amount presently obligated with respect to this contract is \$760,866.00.

3. Section B.11, DURATION OF CONTRACT PERIOD, is revised to read as follows:

The ordering period for this contract shall commence on September 29, 2004 and will expire on September 28, 2007. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)

4. FAR Clause 52.232-19 "Availability of Funds for the Next Fiscal Year" is provided in its entirety.

52.232-19 Availability of Funds for the Next Fiscal Year

Funds are not presently available for performance under this contract beyond December 28, 2006. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond December 28, 2006, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.
