This Modification No. 11 exercises option period 4 of the contract and obligates additional funds in the amount of \$14,000. Accordingly, the following changes are hereby made:

1. Section B.2 CONSIDERATION AND OBLIGATION. Option Period 4 increases the contract ceiling by \$85,696.00 from \$324,582.00 to \$410,278.00. Accordingly, the first sentence in paragraph (a) is revised to read as follows:

(a) The total ceiling amount of this contract for the Base Year, Option Period 1, Option Period 2, Option Period 3 and Option Period 4 is \$410,278.00.

 Section B.2 CONSIDERATION AND OBLIGATION. This modification obligates \$14,000, increasing the obligated amount from \$320,964.00 to \$334,964.00.
 Accordingly, paragraph (b), first sentence is revised to read as follows:

(b) The amount presently obligated with respect to this contract is \$334,964.00.

3. Section B.5, Paragraph XII, PERIOD OF PERFORMANCE, is revised to read as follows:

The period of performance shall expire on September 30, 2007.

4. FAR Clause 52.232-19 "Availability of Funds for the Next Fiscal Year" is provided in its entirety.

52.232-19 Availability of Funds for the Next Fiscal Year

Funds are not presently available for performance under this contract beyond <u>November</u> <u>30, 2006</u>. The Government's obligation for performance of this contract beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond <u>November 30, 2006</u>, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer. (End of clause)

All other terms and conditions remain the same.
