- ✓ 1. Please specify the number of gauges for each model (Troxler Electronic Laboratories, Inc. Models 3411, 3400 Series, and CPN International, Inc. Model MC Series Portaprobe) you plan to possess.
- ✓ 2. Please specify one individual to be named as the Radiation Safety Officer (RSO), Ms. Gretchen Heathman or Mr. Kevin Engelmeier.

Please note that the NRC does not include "Assistant Radiation Safety Officers" (ARSO). Note that the individual listed on the license as RSO is responsible for the overall management of the radiation safety program; identifying radiation safety problems, initiating, recommending or providing corrective actions; verifying implementation of corrective actions; ensuring compliance with the Commission's rules and regulations and conditions of the license. An RSO should actively participate in the day-to-day management of the radiation safety program. Although the performance of certain radiation safety tasks may be delegated by the RSO to other individuals (such as the ARSO), the responsibility for the overall effectiveness of the radiation safety program and for compliance with NRC rules and regulations and conditions of the license reside with the RSO.
