

Block 9) Records related to the radioactive sources will be maintained at the location shown in Block 9. The sources will be stored at a separate secure location when not in being used in conjunction with logging activities at temporary jobsites throughout India.

Block 10a) Appendix P remarks concerning Cs-137. Neither the maximum individual activity of each Cs-137 sealed source (74 GBq / 2 Ci) nor the aggregate total activity of all of the Cs-137 sealed sources for this license application will meet or exceed Appendix P Quantities of Concern thresholds (1000 GBq / 27 Ci). However, when Cs-137 is shipped in conjunction with Am-241, the fractional portion of Am-241 plus Cs-137 may exceed "1" (unity) in a single shipment and thus will exceed the Quantity of Concern per shipment.

Block 13) Dependent upon business need at the time of importation, NSSI may or may not be used as an intermediate consignee.

Block 17a) Authorization from the Indian government (Atomic Energy Regulatory Board) will be furnished to NRC prior to each exportation shipment to India.
