This is in response to your affidavit signed by Mark Fecteau, dated September 8, 2006, requesting that portions of the responses to a Request for Additional Information (RAI) (ML062080326) related to renewal of Materials License SNM-1107, submitted by your letter, also dated September 8, 2006, be withheld from public disclosure pursuant to 10 CFR 2.390.

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- 1. The information contained in the subject documents is confidential commercial information under 10 CFR 2.390(a)(4).
- 2. The information provided is routinely withheld from public disclosure, was submitted to the Commission in confidence, and is not available in public sources.
- 3. The public disclosure of the information contained in the documents would harm the competitive position of Westinghouse since the documents contain substantial sensitive information related to the company's nuclear criticality safety program.

We have reviewed your affidavit and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of your statements, have determined that the submitted information sought to be withheld contains proprietary commercial information.

Therefore, the version of the submitted information marked as proprietary will be withheld from public disclosure pursuant to 10 CFR 2.390(a)(4) and Section 103(b) of the Atomic Energy Act of 1954, as amended. The redacted version of the information, enclosed with your affidavit, will be made publicly available.
