Remarks/Comments/Lessons Learned: OI report found that individual, a general foreman, deliberately failed to take action after two individuals reported the odor of alcohol on a foreman. The call was made based on the two welders report that the incident had happened backed by the statement from three other foreman that the individual had told them after the fact that the welders had come to him. The individual told both the licensee and OI that the incident had never occurred. There is a need with this case to question the existence of a chilled environment as a result of the two welders being laid off for not reporting the FFD concern.
