Remarks/Comments/Lessons Learned: The panel determined that due to the number of disagreements between the individual statements, that a deliberate violation could not be considered. However, there was testimony that two individuals had smelled a tinge of alcohol on the foreman's breath and enough information to determine that the individuals had brought it to their supervisors attention in some manner (if only to bring forward the opinion that the individual had a drinking problem). The two together provided a basis for the supervisor to require a fitness for duty test, but this test was never performed. The supervisor was aware of the requirements, so the failure was considered as careless disregard.
