
Physical Description: Uranium Hexafluoride, fissile. Gross weight: 10,092.0 Kgs; Net UF6 Weight: 5,465.6 Kgs; U Weight: 3,695.28 Kgs; Maximum enrichment 3.803 % UF6 contained in three (3) cylinders. The cylinders will be secured inside protective shipping packages and shipped on one (1) x 20' shipper's owned flat racks.

Transfer Points: Baltimore, MD for unloading from ARRC's vessel "ATLANTIC ACTION", and loading onto ARL trucks for delivery to Garden City Terminal in Savannah, GA for loading onboard Hanjin Shipping vessel "Hanjin San Francisco v.0049W" to Busan, Korea.

Routes to be used: U.S. Inland Routing will be in accordance with 49 CFR 397.101
